Attendance

Reeve Allan H. Steinke, and Councillors Raymond W. Huggart, James H. Cassels, Reginald P. Marginet, Barry W. Hodgins, Ivan Bruneau, Chief Administrative Officer, and Brent Baete Development Officer Building Inspector.

Notice of hearing was given in accordance with the requirements of the Planning Act for all matters under consideration at these hearings.

Conditional Use No. 11/10 – Telus Mobile (Kelly & Tracy Mauws – owners) SW¹/₄ 16-7-12W

Tim Drum of Sutton Realty on behalf of Telus Mobile and Kelly & Tracy Mauws attended in support of their application to construct a telecommunication tower on the southwest corner of the SW¹/₄ 16-7-12W. The tower is approximately 90 meters high and will be secured with 3 guy wires and will provide cell service to the area with eventual service of internet in the future.

Gord Parker of Manitoba Infrastructure and Transportation forwarded a letter advising that they are not opposed to the intent of the change; the setback distance should ensure the tower would not potentially fall with the right-of-way of PTH 2.

Dave Scott of Swan Lake First Nations attended the hearing to advise that there may be buried artifacts located at the proposed site. Mr. Scott advised that he was not opposed to the construction of the tower and requested to be in attendance when the construction work would be initiated.

Paul Hutlet advised that his father had worked on the highway when PTH 2 was originally constructed. Bones had been found along the construction area of the highway, which had been removed. Although not sure of the exact location he believes thought that it should be known that there could be the potential of additional remains near this area.

Variation No. 12/10 – Vince Jonk, (Heritage Haven Incorporated – owner) SE¹/₄ 24-7-12W

No representations were made or received for or against the application for Variation.
