The delegation met with Council to present their water pipeline proposal. Their proposal involves pumping water from the Assiniboine River to their water reservoir at Landseer. They are requesting to be granted access along River Road at Bear Paw Gulch. Most of the other accesses would be provided onto private easement, however at some locations the only access available may be along the Road Allowances. This project is currently in the early planning stages and may not be provided for some time until all the approvals and estimates for construction have been received.

# C.4 3:00 pm – Brad Marginet – Marginet Potato Growers

Mr. Brad Marginet of Marginet Potato Growers met with Council to review their proposal to install an irrigation pipeline along the south side of Road 47North between Roads 58 West and 59 West, to their property at  $NE\frac{1}{4}$  30-8-10 WPM.

# C.3 4:00 p.m. – Member of Parliament Candice Bergen – Portage-Lisgar Constituency

Member of Parliament Candice Bergen met with Council to discuss issues of concern to Council. In particular, Council reviewed the dilapidating condition of Highway #34, and funding of rural water distribution pipelines. Rural Water Pipeline funding was previously funded through the federal government through Prairie Farm Rehabilitation Administration. At present funds have been funneled through the provincial Growing Forward Fund. The Federal Government has plans to announce a Infrastructure Building program sometime in the future. Council reviewed the concerns that have with the funding being cut from the national Prairie Farm Rehabilitation Administration program. Member of Parliament Bergen spoke regarding the XL Beef Processing plant in Alberta and the events that have developed. Council also wanted to re-affirm the plight of the cattle industry throughout the prairie provinces.
