PUBLIC NOTICE is hereby given that the 2027 General Assessment Roll of the Rural Municipality of Victoria deposited with the Chief Administrative Officer is open for public inspection at the Municipal Office at Holland, Manitoba during regular business hours. Applications for revision may be made in accordance with Sections 42 and 43 of the Assessment Act:

APPLICATION FOR REVISION

42 (1) A person in whose name property has been assessed, a mortgagee in possession of property under Section 114(1) of The Real Property Act, an occupier of premises who is required under the terms of lease to pay the taxes on the property, the authorized agent of the person, mortgagee or occupier, or the assessor may make application for the revision of an assessment roll with respect to:

- a) liability of taxation;
- b) amount of an assessed value;
- c) classification of property; or,
- d) a refusal by an assessor to amend the assessment roll, under Subsection 13(2).

APPLICATION REQUIREMENTS:

43 (1) An Application for Revision must:

- a) be made in writing;
- b) set out the roll number and legal description of the assessable property for which a revision is sought;
- c) set out which of the matters referred to in subsection 42(1) are at issue, and the grounds for each of those matters; and,
- d) be filed by;
 - I) delivering it or causing it to be delivered to the Municipal Office, 130 Broadway Street, PO Box 40, Holland, Manitoba, R0G 0X0; or,
 - II) serving it upon the Chief Administrative Officer,

at least 15 days before the scheduled sitting date of the Board as indicated below.
